(e.g., Sporting Shooters Association of Australia or Queensland Rifle Association or Archery Associations); <b>AND</b></li> <li>• Details of any affiliation with any historical association (State, National and/or International); <b>AND</b></li> <li>• Details of your Public Liability Insurer; <b>AND</b></li> <li>• A list containing between 10 and 30 names of the proposed initial weapons club members including full name, address, date of birth and details of any Weapons Act licenses held; <b>AND</b></li> <li>• Provide information that will demonstrate your knowledge and understanding of the safety obligations of an approved weapons club; <b>AND</b></li> <li>• Details of all construction, equipment and location of the proposed range site; <b>AND/OR</b></li> <li>• Details of any firing rights that have been arranged with another approved club or association for use on their approved shooting range.</li> </ul>
