2. REQUIRED CATEGORIES

Category M Weapons
As contained in Section 7A(g) of the Weapons Categories Regulation 1997
• Any crossbow designed to be discharged by the use of two hands that, when discharged, is capable of causing damage or injury to property or capable of causing bodily harm.

3. FURTHER INFORMATION REQUIRED

In support of your application, you MUST ensure that you provide the following information and/or documentation.
• Provide proof of current financial membership of an approved weapons club for historical or military re-enactment—demonstrated use.
• Provide proof of current financial membership of an approved weapons club for historical or military re-enactment—training.
• The proof is to clearly show the name of the club, your name and the expiry date of membership.

4. COURSE IN SAFETY TRAINING FOR WEAPONS

1. Provide details of any current weapons licence held;
2. Provide details of any crossbow(s) held and the date of acquisition;
3. If applicable, provide proof of the successful completion of an approved course in safety training crossbows—a 'Statement of Attainment' issued within the last twelve months, detailing the date the certificate was awarded, the categories of weapons in which you have been deemed competent, and the name of the registered training provider.

5. PROOF OF IDENTITY

If you are the holder of a current Weapons Act licence of another type, you are not required to complete another Form 30 Proof of Identity Declaration or supply recent photographs UNLESS—
1. A period of not more than 3 years has elapsed since you provided proof of identity and photographs; or
2. The current licence card does not reflect an accurate likeness of you (e.g., have you grown or removed a beard since the issue of the licence card?).

6. CERTIFICATION

I certify that the reason outlined in this Annexure is a genuine and necessary reason for my possession and use of weapons AND I have attached any relevant supporting documentation.
