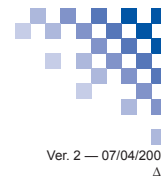

APPLICATION FOR A LICENCE  
**ANNEXURE—OCCUPATIONAL - ARMOURER’S**

You are required to satisfy the Authorised Officer that you have a genuine reason to hold a licence.  
**Please PRINT the required information clearly and legibly.**

**1. APPLICANT DETAILS**

*This information is required to support your genuine reason and must be attached to your application.*

1. Indicate which categories of weapons you intend to perform the functions of an armourer for, by crossing  the WHITE boxes.

Refer to the ‘Guide to Form 1 Application for a Licence’ for category descriptions.

- Provide advice of the security precautions to be taken to ensure the safekeeping of all weapons to be stored including an indication on whether or not these precautions meet the requirements of sections 30–38 of the *Weapons Regulation 1996*.
- Provide a copy of current registered business/company name providing details of the type of enterprise (e.g., sole proprietor, partnership, etc.), including the extract detailing the office holders of the company/business.
- Provide written approval from your local council certifying the intended land use for the business is in compliance with local by-laws.
- Provide details of all qualifications and experience relevant to perform the functions of an armourer. This may be in the form of a resume, and may contain referees from person(s) within the industry.
- Outline what type of work you intend to undertake.
- Where do you intend undertaking this work?
- What skills do you possess that allow you to perform the functions of an armourer having regard to individual and public safety?
- What equipment do you have to enable you to perform the functions of an armourer?

**2. PROOF OF IDENTITY**

*Do you need to attach Proof of Identity?*

**If you are the holder of a current Weapons Act licence of another type, you are not required to complete another Form 30 Proof of Identity Declaration or supply recent photographs unless—**

- A period of not more than 3 years has elapsed since you provided proof of identity and photographs; or
- The current licence card does not reflect an accurate likeness of you (e.g. have you grown or removed a beard since the issue of the licence card?).

**3. COURSE IN SAFETY TRAINING FOR WEAPONS**

*Do you need to complete a Course in Safety Training for Weapons?*

- Provide details of any current weapons licence held; **OR**
- Provide proof of the successful completion of an approved course in safety training for weapons—a ‘Statement of Attainment’ issued within the last twelve months, detailing the date the certificate was awarded, the categories of weapons in which you have been deemed competent, and the name of the registered training provider.

**4. CERTIFICATION**

I certify that the reason outlined in this Annexure is a genuine and necessary reason for my possession and use of weapons **AND** I have attached any relevant supporting documentation.
