4. PROOF OF IDENTITY

1. A period of not more than 5 years has elapsed since you provided proof of identity and photographs; **OR**
2. The current licence card does not reflect an accurate likeness of you (e.g. have your grown or removed a beard since the issue of the licence card)

5. COURSE IN SAFETY TRAINING FOR WEAPONS

- 1. Provide details of any current weapons licence held; **OR**
- 2. Provide proof of the successful completion of an approved course in safety training for weapons—a 'Statement of Attainment' issued within the last twelve months, detailing the date the certificate was awarded, the categories of the weapons in which you have been deemed competent, and the name of the registered training provider.

6. CERTIFICATION

I certify that the reason outlined in this annexure is a genuine and necessary reason for my possession and use of weapons **AND** I have attached any relevant supporting documentation.
