Occupational Use/Special Occupational Reasons—Provide a letter on a business letterhead outlining that the licence is required in the conduct of your business/occupation and describing the duties that require the use of weapons.

Government Service Entity—Provide a letter from your employer verifying that you are employed by a Government Service Entity and outlining the duties for which firearms are necessary.

Animal Control—If you are an employee of a Council or Authority, provide a letter from your employer verifying the reason(s) why firearms are necessary and the nature of the duties undertaken.

COMMERCIAL FISHER

Commercial Fisher—Provide a copy of your **CURRENT** boat registration documentation **AND** a copy of your **CURRENT** Commercial Fisher Licence, issued by the Department of Primary Industries **AND** provide details of the type of business conducted and reasons why a firearm is necessary. **If you require the use of powerhead weapons provide details as to the duties that a weapon of this type is required for.**

COMMERCIAL WILDLIFE HARVESTER

1. Select the categories of weapons you wish to apply for by crossing the WHITE box(es)

Commercial Wildlife Harvesting—Provide a copy of your **CURRENT** Commercial Wildlife Harvesting Licence, issued by Queensland Parks and Wildlife Services **OR** a Letter of Intent from Queensland Parks and Wildlife Services to issue you with a Commercial Wildlife Harvesting Licence when you become the holder of a firearms licence.

ACCREDITED GAME MEAT HARVESTER

Accredited Game Meat Harvester—Provide a copy of your **CURRENT** Certificate of Accreditation issued by Safefood Queensland **AND** a letter from a property owner authorising you to shoot on the property owner's land. The letter is to detail the location, total area and description of the property.

2. Provide proof of the successful completion of the approved training course for Security Licence (Guard). Provide a 'Statement of Attainment' issued within the last 12 months containing the following information: the date the certificate was awarded, modules completed in the course, the categories of weapons in which you have been deemed competent, and the name of the registered training provider **OR** details of any current weapons licences held.
3. Provide evidence of your current Training Organisation Registration with the Department of Education and Training (D. E. T.) as an approved provider of the 30989QLD and/or an approved training course for weapons **OR** a letter of authorisation from a registered provider of a course approved by the Commissioner under the *Weapons Act 1990*. This letter should contain details of: the registered number of the registered course provider, the courses you are authorised to instruct, the period of time the authorisation is valid, and where the course instruction will take place.
4. Provide evidence of your qualification and/or experience in relation to the development, presentation and evaluation of modules, and assessment of participants (minimum requirement—possess Certificate IV for Workplace Training).
5. Provide evidence of your practical experience in the handling and use of weapons. This may be presented in the form of a resume and include copies of the relevant certificates, awards and proof of membership.

2. Provide a letter from the Paintball Field Official stating that you are an employee of the business.

2. PROOF OF IDENTITY

If you are the holder of a current Weapons Act licence of another type you are not required to supply a photograph UNLESS -

1. A period of not more than 10 years has elapsed since you provided proof of identity and photographs; **OR**
2. The current licence card does not reflect an accurate likeness of you (e.g. have you grown or removed a beard since the issue of the licence card?)

3. COURSE IN SAFETY TRAINING FOR WEAPONS

1. Provide details of any current weapons licence held; **OR**
2. Provide proof of the successful completion of an approved course in safety training for weapons—a 'Statement of Attainment' issued within the last 12 months, detailing the date the certificate was awarded, the categories of the weapons in which you have been deemed competent, and the name of the registered training provider.

4. CERTIFICATION

I certify that the reason outlined in this Annexure is a genuine and necessary reason for my possession and use of weapons and I have attached any relevant supporting documentation.
