## (d) Group Licence (Other) (e.g., Council)

1. Select the categories of weapons you wish to apply for by crossing the WHITE box(es).



- 2. Provide a letter on business letterhead containing the following information:
  - The position held by the author of the letter in the company / business;
  - Authorisation for the applicant to be representative for this application;
  - Details of activities which warrant the use of weapons.
- 3. Provide a copy of the current registered business/company name providing details of the type of enterprise (e.g., sole proprietor, partnership, etc.) including the extract detailing the office holders of the company/business. If the applicant is a shooting gallery operator provide details of the shooting gallery approval number.
- 4. Details of the storage facility where weapons are to be stored, and its compliance with legislation.
- Note 1: A group licence may be issued to an individual or a body and can include the licence classes of a firearms licence, a firearms licence (instructor), a concealable firearms licence or a miscellaneous weapons licence for genuine reasons such as sports or target shooting, animal control or firearms instructor.
  - To support your application, you should include required information pertaining to your genuine reason. Please refer to the appropriate Form 1 Annexure relating to your specific genuine reason.
- Note 2: A group licence may also be issued to shooting gallery operators or any other target shooting organisation that does not hold a separate shooting club approval, or any other business requiring the use of firearms in the conduct of their business.

## (e) Miscellaneous Licence (Including Historical, Military and Martial Arts)

1. Select the categories of weapons you wish to apply for by crossing the WHITE box(es).



#### **Applications for Category E**

1. Provide written details of the special occupational need, or the exceptional need for self-preservation that cannot be satisfied in another way.

#### Applications for Historical, Military or Martial Arts purposes (Category M only)

- 1. Provide specific details of the reasons why the weapon(s) are required including:
  - When the weapon(s) are required for physical possession; and
  - Where the weapon(s) are required for physical possession.
- 2. Provide proof of current financial membership that:
  - Is, or is affiliated with, a State, national or international historical, military re-enactment or martial arts organisation; or
  - Is a genuine historical, military re-enactment or martial arts organisation that gives training in the use of the type of weapon(s).
- 3. Provide a current letter of authorisation from the organisation you represent, which includes a description of the activities for which the weapon(s) are required.
- 4. Provide a detailed description of the weapon(s) used by the organisation (martial arts requirement only).

## (f) Military Re-Enactment or Historical Demonstration

1. Select the categories of weapons you wish to apply for by crossing the WHITE box(es).



Provide proof of CURRENT financial membership of a recognised military re-enactment club/society. The proof is to clearly show your name and the expiry date of membership and must be for the category(ies) of weapons endorsed on your firearms licence.

#### 2. PROOF OF IDENTITY

if you are the holder of a current Weapons Act licence of another type you are not required to supply a recent photographs UNLESS -

- 1. A period of not more than 10 years has elapsed since you provided proof of identity photographs; OR
- 2. The current licence card does not reflect an accurate likeness of you (e.g., have you grown or removed a beard since the issue of the licence card?)

## 3. COURSE IN SAFETY TRAINING FOR WEAPONS

- I. Provide details of any current weapons licence held; OR
- 2. Provide proof of the successful completion of an approved course in safety training for weapons a 'Statement of Attainment' issued within the last twelve months, detailing the date the certificate was awarded, the categories of weapons in which you have been deemed competent, and the name of the registered training provider.
