**CONDITIONS OF RECEIPT OF THE SAID PROPERTY**

1. In the event that a more recent Will is located at a later date, I undertake to ensure that I have the correct authority to maintain the possession of the firearm/weapon.
2. In the event of the rightful owner establishing his/her lawful claim to the firearm/weapon, I undertake to return it, or pay the value of it, or hand to a Queensland Police Station until such claims are finalised.
