Application for Extension - Release Application and Internal Review

Police Powers and Responsibilities Act 2000 Sections 123G(4) & 123L(2)

Used by the affected owner (the applicant) of a seized vehicle to apply to the Commissioner of Police for an extension of time to submit an Application for Release of Seized Vehicle or a Application for Internal Review of Decision of Release Application (Seized Vehicle PPRA 123G).

Note: This is not an application for release or an internal review but only serves the purpose of an application for extension to submit either of those forms.

Your application for an extension must be submitted within the applicable time frame: 30 days for a Release Application or 28 days for an Internal Review.

Parts marked with an asterisk (*) must be completed in full.

For example, you have contacted the manufacturer of your device and are waiting for them to provide information about your device's specifications. Please see attached email.

Provide details that demonstrate the grounds for an extension.

Include a copy of any other documents you plan to use as evidence to support your reason for review.

If you are riding a vehicle owned by a shared e-mobility provider, your personal information may be disclosed to that provider in accordance with law. To submit application

You can lodge your application by printing this form and lodging at your local police station.

Once the delegate has assessed your request for an extension you will be advised by email or text.

If your application is approved, you will have 30 additional days to apply for release and 28 additional days to request an internal review, starting from the date you receive confirmation of the extension.
